FINANCIAL ASSISTANCE



Hawaiian Telcom has financial assistance/discounts for their Internet and Home Phone Services for qualified individuals.

Internet Kokua. This Program provides a discount on Internet services for individuals who meet certain income qualifications. Customers may be eligible to receive high-speed Internet Basic service for \$9.95/month; or Internet Ultimate service for \$12.95/month, if you home is fiber service enabled.

Federal Emergency Broadband Benefit. This is a temporary federal government program which provides eligible consumers with a discount of up to \$50 per month for broadband service.

Lifeline. The federal Lifeline program provides discounts on local home phone or Internet service if you live in an eligible area and meet certain income qualifications.

Hawaiian Electric has payment arrangement options for those who may be experiencing financial hardship due to COVID-19. They are offering interest free payment plans for both residential and commercial customers; and late fees are waived for all payment options.

There are installment plans ranging from 4 months to 18 months where equal monthly payments are made over the agreed upon period of time.

There is also a Deferred Start Installment plan lasting 4, 6, or 12 months. Equal installment payment of the balances will be paid over 4, 6, or 12 months, but the first payment is deferred for two months, depending on the option selected and the past due balance at that time. To qualify for this option, you must demonstrate financial hardship.

For all of the installment plans, you must make on-time payments for the duration of the installment period.

UNEMPLOYMENT REOPENS

The state Department of Labor & Industrial Relations (DLIR) announced that it will be opening its offices statewide beginning **December 1, 2021**. Services from all DLIR programs will be available Wednesdays through Fridays. Telephone appointments for general unemployment insurance and claims adjudication will continue on Mondays and Tuesdays.

Persons seeking in-person services will be required to show proof of full vaccination or negative test results prior to the entry of all offices, as outline in Governor Ige's Executive Order 21-07. In addition to providing proof of full vaccination or negative test results, you must wear a mask.

DLIR will continue to offer telephone appointments for the Pandemic Unemployment Assistance (PUA) program and employer services Mondays through Fridays, and claims adjudication and general unemployment insurance inquiries on Mondays and Tuesdays.

SCAM ALERT

Hawaiian Electric (HECO) is warning of a scam targeting real estate agents. Real estate agents who have houses listed for sale are being threatened by scammers that the house has an outstanding electric bill and must be paid or the electricity will be disconnected. If the scammers are told that payment would be made on the HECO website, the real estate agents are told to pay by wire transfer. HECO reminds customers that it will never threaten immediate disconnection if payment is not made. HECO also does not demand payment by wire transfers, prepaid debit cards, gift cards or Bitcoin payment.

If you suspect a scam, you are urged to report this to HECO.
