Councilmember Elefante Chairs the Large Cities Council in 2022

At the end of 2021, Councilmember Brandon Elefante was re-elected to serve a second term on the Board of Directors for the National League of Cities (NLC). The NLC is comprised of city, town, and village elected leaders focused on improving the quality of life for their constituents.

Councilmember Elefante was asked to serve as the Chair for the Large Cities Council (LCC) this year by the NLC President, Union City Georgia Mayor Vince Williams.

The LCC consists of NLC member city elected officials from cities with a population of 200,000 or more. The objective of the LCC is for members to share ideas and successful strategies that solve the unique challenges affecting large cities like our City and County of Honolulu. Their next meeting will be at the Congressional City Conference and City Summit to be held this March in Washington, DC.

City Urges Residents to Use Its Free Service to Tow Junked Vehicles

It's a new year, and perhaps you're thinking about making some space in your garage. The City's Motor Vehicle Control Section urges residents who need this free service to get rid of their unwanted vehicles. Each year, the City's free Junked Vehicle Program takes in unwanted cars from owners who surrendered them. In 2020, the City took in nearly 1,000 vehicles, which was a sharp decline from the nearly 1,600 vehicles that were junked in 2019.

On our island, approximately 1 in every 5 unwanted vehicles was towed in 2020 after ending up curbside on public roadways. By comparison, about 1 in every 3 unwanted vehicles in 2019 was towed after being illegally dumped. So, while people are dumping less vehicles year over year, it is still a real issue for the environment and for our island's natural beauty.

Junking a vehicle requires turning in a junking form, the license plates, registration, and title to a satellite city hall. The vehicle must be free of trash, accessible by a tow truck, and have at least two inflated tires for it be towed.

While the junking service and towing are free, please note that surrendering a vehicle to the City does not relieve the owner of any financial responsibility such as liens, criminal charges, or citations. Community Development Block Grant Funds for Public Services And Economic Development Projects

The Community Development Block Grant (CDBG) Notice of Funding Availability (NOFA) for FY 2023 Public Services and Economic Development projects was posted to the State of Hawaii's Hawaii Awards & Notices Data System (HANDS) website.

Up to \$790,000 in Fiscal Year 2023 CDBG funds are being made available for public service and economic development projects in eligible communities throughout Oahu. To qualify for consideration, the public service must be a new service or a quantifiable increase in the existing level of a service. Only applications requesting at least \$100,000 will be considered. Applicants must submit a proposal requesting at least \$100,000 and up to \$200,000, and they may elect to include a supplemental budget up to an additional \$100,000, to be awarded upon funding availability.

The City has previously made funds from the CDBG Program, Emergency Solutions Grants ("ESG") Program, Ohana Zone Program, and the Coronavirus Aid, Relief and Economic Security Act ("CARES Act") available to the community. Given that, priority under this NOFA will be given to projects that are not currently contracted to receive funds. Priority will also be given to projects that involve one of the following activities: employment services, including job training; support services for senior citizens; and nongovernmental educational activities. Priority will be given to projects that will begin benefitting clients during Fall 2022.

Interested parties can find the solicitation on the "State of Hawaii – Hawaii Awards & Notices Data System (HANDS)" webpage for all formal solicitations for goods, services, construction, grant,s and concessions. HANDS gathers information from multiple state and county procurement platforms and displays it all in one place. Department of Parks and Recreation Survey on Rules for Shore Water Events

The Honolulu Department of Parks and Recreation (DPR) is inviting members of our community to share their opinions regarding proposed revisions to rules governing Shore Water Events around O'ahu.

Shore Water Events typically include activities that involve permitted use of coastal and beach areas for the purpose of accessing the ocean such as: surf contests, canoe regattas, triathlons, and swim races. These rules are designed to work in tangent with ocean permitting and usage guidelines facilitated by the State of Hawaii.

The survey questions focus on proposed revisions to DPR's Shore Water Rules that include possible changes to regulations regarding gender equity, event parameters, and impacts of Shore Water Events on the community.

The survey is now open and will be closed on Wednesday, Feb. 16, 2022 at 11:59 p.m. (HST). You can access the survey on this website: bit.ly/shorewatersurvey
