On **Tuesday, March 8 at 9 am**, HART's Executive Director and CEO Lori M.K. Kahikina, P.E., briefed the Honolulu City Council's Budget Committee and presented HART's FY23 operating and capital budgets. Highlights include a 13% reduction in the operating budget from FY22.

Monday Traffic Update



From **Monday, March 21, 2022** through **Friday, April 8, 2022**, there will be daytime alternating and intermittent closures of inbound and outbound Pupukahi Street at the Farrington Highway Intersection in Waipahu. These closures will occur between **8:30 am** and **3:30 pm** from **Monday through Friday**.

HART's contractor will be alternating the location of the lane closure as work progresses. Crews will be installing conduit and electrical wiring at the intersection.

- When crews close the outbound travel lanes of Pupukahi Street onto Farrington Highway, motorists will be detoured to Pupupuhi Street. The inbound lanes into Pupukahi Street will remain open.
- When crews close the inbound lanes of Pupukahi Street from Farrington Highway, inbound motorists will be detoured to Pupupuhi Street or Leokane Street. The outbound lanes of Pupukahi Street onto Farrington Highway will remain open.
