## TAX REFUND DISTRIBUTION

Governor David Ige announced the distribution schedule for the highly anticipated, one-time, constitutionally required, tax refund to Hawaii residents who filed income tax returns for 2021. In the first round of refunds, approximately 100,000 taxpayers will receive their refund by direct deposit or mail on our about September 12. Two additional distribution are scheduled for September 9 and September 13, completing the bulk of the direct deposit refunds.

For those taxpayers who are receiving paper refunds, paper check refunds will be sent out in patches of 2,000 until additional check stock is received. Once the additional check stock is received, paper refunds will be sent out in batches of 90,000 per week.

If you have elected to receive your refunds by direct deposit, when you filed your 2021 income tax return you will receive this tax refund by direct deposit. If you have elected to receive your refund by paper check, you will receive this refund by paper check. You may not switch methods of receiving this tax refund.

If you filed your income tax return by July 31, and are expecting a paper check, you should receive your refund by the end of October. If you filed your tax return after July 31, you should receive your refund about 10 weeks after your tax return is accepted by the Department of Taxation. If you would like to receive this tax refund, but have not filed your 2021 state income tax, you have until December 31 to file your tax return in order to be eligible for the refund.

- Taxpayers who earn up to \$100,000 per year, or couples who earn up to \$200,000 per year, will receive \$300 each, including each dependent.
- Taxpayers who earn over \$100,000 per year, or couples earning \$200,000 or more, will receive \$100 each, including each dependent..

In addition to qualifying for the tax return, besides filing your 2021 State of Hawaii income tax return in a timely manner, you must also have been a resident of the State of Hawaii for at least 9 months.

## **DMV ROAD TESTS ON SATURDAYS**

If you or your child are having a difficult time scheduling road tests, there is some relief. You may schedule AlohaQ appointment services or road tests for certain Saturdays until the end of the year. Services include license/ID renewals and duplicates, out-of-state transfers, road tests and written exams.

- Kapalama Driver Licensing Center: September 10, October 8, November 5, and December 3.
- Sheridan Park Road Test Office: September 17, October 1, November 19, and December 3.
- Kapolei Driver Licensing Center: September 17, October 22, November 17, and December 17.

Road tests are by appointment only at the Kapolei and Sheridan Park Centers. There will be stand-by services during the Saturday hours at Kapolei and Kapalama, but **same day service is not guaranteed**. The stand-by service is offered to off set the no-shows and cancellations for appointments.
