NCTF-RH Safety Programs Focus on Worker and Contractor Safety

Navy Closure Task Force-Red Hill prioritizes worker and contractor safety while operating inside the Red Hill Bulk Fuel Storage Facility. This is done through our robust safety programs. These measures ensure that workers are safe when entering and working in the tanks and throughout the facility.

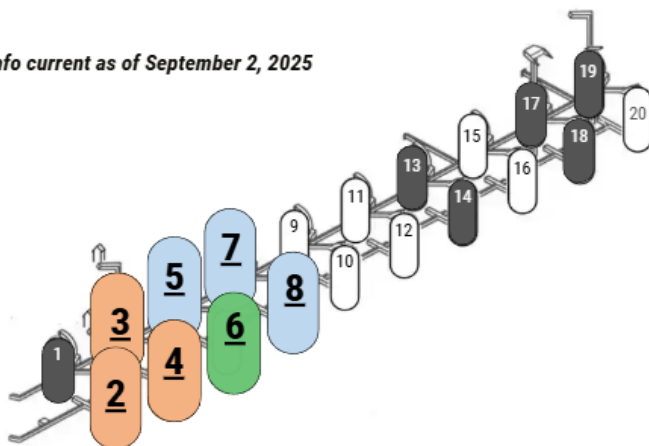
Confined space entry protocols include understanding confined spaces requirements, monitoring air quality, ensuring proper ventilation, and using safety equipment, which include lifelines to prevent falls.

In addition to the command's safety programs, personnel working in the tanks or elsewhere in the facility follow all Occupational Safety and Health and (OSHA) standards for personal protective equipment and other precautions as appropriate for the work being performed.

Step 2: Remove Solid Sludge (approx. 2-3 months)

Step 3: Pressure Washing (approx. 1-2 months)

Step 4: Tank Decommission (approx. 1-2 months)

NCTF-RH Provides Tank Cleaning Update

Tank cleaning operations continue at the Red Hill Bulk Fuel Storage facility and remain on schedule.

Teams are currently inspecting and repairing the center towers in Tanks 2, 3 and 4. Tank 6 is being prepared to be pressure washed, and tanks 5, 7, and 8 are in the final stages of cleaning verification.

The team is preparing to degas tank 20 in October, making it the eighth tank to undergo this initial process to clean and eventually close it.
